Directions

From Merritt Pkwy North

Take Exit 49N toward Danbury onto Ct- 25. Continue until the highway comes to a traffic light. At the light, take a right onto Rt. 111. Go to the 4th traffic light and make a left onto Technology Drive. We are in the second building on the left, #115 Technology Drive, Suite B101.

From Merritt Pkwy South

Take Exit 49 toward Danbury onto Ct- 25. Continue until the highway comes to a traffic light. At the light, take a right onto Rt. 111. Go to the 4th traffic light and make a left onto Technology Drive. We are in the second building on the left, #115 Technology Drive, Suite B101.

From I-95 North or South

Take Exit 27A onto Route 25/8 North. Follow for 3 miles until the highway divides and stay to the left onto Route 25 to Trumbull. Continue until the highway comes to a traffic light. At the light, take a right onto Rt. 111. Go to the 4th traffic light and make a left onto Technology Drive. We are in the second building on the left, #115 Technology Drive, Suite B101.
